

A complete set of Tendering Documents in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of **Tshs.150,000.00**. Payment should be by Cash, payable to **NEWALA District Council**.
7. All Tenders must be accompanied by a Specific Tender Security for the particular project in an acceptable form in the amount of 10% total bid sum in local or foreign currencies
8. All Tenders in **one** original plus **two copies of the original**, properly filled in, and enclosed in plain envelopes must be delivered to the following address:-
